We may revise this agreement anytime and occasionally without prior notice. The latest agreement shall be seen on the website, and you should review this agreement prior to using the site.

We reserve the right, and you authorise us, to the use and assignment of all information regarding site uses by you and all information provided by you in any manner consistent with our privacy policy.

By placing an order, you agree to receive regular newsletters at your registered email address. Naturally, you can unsubscribe from our newsletter anytime.

Orders

If you choose bank transfer as the payment method, please note that the payment has to be credited to our account, and only then can we start production or dispatch the goods. As sometimes it can take 1-2 days, please send us proof of payment by email. Then, we can dispatch the parcel or start printing your ordered items. This can make the turnaround time shorter. Lead times on our webshop are only for your reference, therefore, the actual production and delivery turnaround time may differ. The production turnaround time depends on our current capacity. Please note placing an order online does not mean a contractual relationship. The contract becomes effective once we send you the order confirmation. (The automatic notice sent by our webshop is just for your information about the successful order, but this is still not a confirmation). We reserve the right to reject an order before confirmation without justification.

Graphics

The artworks/designs we created are the property of Wristbands DCD Ltd. These cannot be used in cooperation with other companies without our written consent. In the case of printed items, we only start production after we receive a written confirmation from the customer about the design proof.

We can only accept a complaint about the graphics if the design of the delivered items differs from the approved design proof.

Payments

If you place an order with us, you warrant that any credit card details you supply are accurate, correct and complete. Charges incurred by you will be honoured by your credit card company, and you will pay the charges incurred at the posted prices, including any shipping fees and applicable taxes.

In the case of payment via the Stripe system, if the customer files a dispute without prior consultation with Wristbands DCD Ltd, a £20 dispute fee will be charged. If the customer submits a refund request to Wristbands DCD Ltd, but Wristbands DCD Ltd fails to respond within 8 days or does not request a deferral, Wristbands DCD Ltd will not be entitled to charge a dispute fee.

Shipping

The wristbands will be delivered to the address given in the "Delivery address" field.

The delivery times stated on the website are only for your information. Wristbands DCD Ltd. does not take any responsibility for the delays caused by the delivery company. Please consider the items are produced and dispatched from the European Union. Please note that, for example, weather conditions or customs clearance since Brexit may also affect the actual delivery turnaround time. Our delivery partner only delivers packages according to its own terms and conditions. The risk of delays during delivery is on the customer's side, so the value of the order is not refundable in the event of such delays.

Upon submitting your order, the system will automatically send you a notification containing the package number, which will enable you to track your parcel. Should any issues arise during the delivery process, it is the customer's duty and responsibility to establish contact with the designated courier company and provide them with the necessary delivery-related information and additional data. Please be advised that we are unable to contact the courier company due to the fact that it is the customer's responsibility to ensure that the provided address allows for unambiguous identification of the recipient and location by the courier. Furthermore, we are not privy to the local circumstances that may aid in this identification process. If the courier company is unable to clearly identify the recipient and address based on the provided data, or if there are any uncertainties, they will dispatch a notification to the recipient in

order to seek clarification. Naturally, should such a situation arise, we will promptly notify the customer as well, requesting them to establish contact with the courier service.

If the products that you ordered are not in stock, the turnaround time will be longer, but it cannot exceed 30 working days. If you have already paid for the goods in advance and any problem occurs during the order process that we cannot solve in time, we will refund your payment.

Where next-day delivery is unavailable with express service, Express delivery takes at least two working days, and Standard delivery takes at least three working days.

Please note that deliveries outside of the UK may be longer. The shipping parity of orders delivered outside of the UK is DAP. Therefore, local customs taxes and VAT may be applied upon delivery.

Cancel an order

For the cancellation of an order, our written permission is necessary.

In the case of plain wristbands, lanyards and other items, we can only cancel the order before the package is handed over to the delivery company.

Returning of goods

If you found damaged goods when you first checked your package, you can send those back within 14 days. The returned package must contain a copy of your invoice and a written description of the detected faults/injuries. The goods can be returned at the customer's own expense.

The products cannot be returned without our prior written consent.
